I Verified 4 Clubs across the region for LFE and was involved in the writing, monitoring, facilitating Assessing and Verification of their NVQ Level 2 programmes. This became an elite team and our efforts meant we achieved grade 1 in Ofsted in 2015. During this time, I trained as an External Verifier with Industry Qualifications verifying various NVQ Leisure and Fitness Industry courses across the Country. I also tutored for Anglia Ruskin University on their first workbased football degree course for 12 months while supporting 1st team Squad candidates through the programme. This was the first programme of its kind which was originally a proposal put forward by myself to the University.

My work experience in the Sport and Leisure industry has been vast and varied since University where I gained experience as a coach in a variety of disciplines, a Recreational Assistant, a Lifeguard and as a Duty Manager. During this time, I ran a sports consultancy business, this involved working for many organisations designing resources, managing events, projects, assessing, internal verifying, quality assurance and compliance. Another was a 2-year project for Healthy Living Solutions working in hard to reach areas with disadvantaged families on healthy eating and exercise, which proved to be an outstanding success and financially profitable for the business.
